## **BLOCK PARTY/STREET CLOSURE PERMIT APPLICATION**

*Please submit this application at least forty five (45) days prior to the proposed event.*

All submissions must include:

- Completed and signed application, including a sketch of the streets affected and where barriers will be placed, and signed acknowledgement of at least seventy five percent (75%) of properties affected by the street closing.
- Copy of letter to be delivered to all affected properties, notifying them of the proposed Block Party.
- \$25 Non-refundable application fee (cash or check made payable to the Borough of Metuchen).

Please note:

- All items and/or equipment placed in the street must be temporary and easily removed to permit emergency vehicle access. Rides, bounce houses, and other amusements are not permitted on the street or any other piece of Borough property during a block party.
- Block Party/Street Closure Permits are limited to two (2) per calendar year per block or portion of a street.
- Street closures for block parties are limited to eight (8) continuous hours. All block parties must end no later than 10 p.m.
